

“UNI.LU Employee and Student Satisfaction” Surveys Lottery Terms and Conditions

1. By entering the “UNI.LU Employee and Student Satisfaction” Surveys Lottery (the “Lottery”), the participants (the “Participants”) agree to be bound by these Terms and Conditions (“The Terms”).
2. The participation to the Lottery is free and does not require from participants any purchase obligation.
3. The Lottery is organised and operated by the University of Luxembourg, having its registered office at 2 avenue de l’Université, L-4365 Esch-sur-Alzette, and registered with the Trade and Companies Register of Luxembourg under number J20 (the “Organizer” or “University” or “UL”).
4. The Organizer reserves the right to amend the Lottery, or these Terms at any time without prior notice.
5. In the event of any dispute regarding conduct, results and all other matters relating to the Lottery, the decision of the Organizer will be final and no correspondence or discussion shall be entered into.

Section 1 – Participation Rules and Registration for the Lottery

1. To be eligible to participate in the Lottery, participants must be students or doctoral students at the University of Luxembourg at the time of the surveys, and must have completed one of the theses surveys, the one for students by midnight on 13th December 2021 or the one for doctoral students by midnight on 15th November 2021. Students and doctoral students will be invited to participate by an e-mail sent by ILRES S.A. during October - November 2021.

2. Winners will be selected by a random draw from all entries by ILRES S.A., with registered office at 41, rue du Puits Romain, L-8070 Bertrange, registered with Luxembourg Business Register under number B16186. ILRES S.A. realizes the satisfaction surveys on behalf of the UL. The draw will be conducted no later than 10 working days after the closing dates.

3. We reserve the right to disqualify any Participant if we have reasonable grounds to believe the Participant, as entrant to the Lottery, has significantly breached any of these Terms.

4. There is no fee payable to you in respect of your involvement in the Lottery. There is no purchase requirement to enter the Lottery.

Section 2 – Lottery Rules and Awards

1. The purpose of this Lottery is to reward the Participants for their involvement in the Employee Satisfaction Survey and Student Satisfaction Survey.
2. Awards will be granted to 110 Participants (100 students and 10 doctoral students) after random drawing. Each winner will receive from ILRES S.A. a Letzshop voucher of a 25,00.-euros value.
3. Prizes will be sent by e-mail sent to the e-mail address held on record for the winning participant. Prizes will be sent no later than 14 days after the draw takes place.

Section 3 – Intellectual Property Rights

1. For the avoidance of doubt, all rights in the name, logo and title of the Lottery and the format rights for the Lottery will vest exclusively and respectively in the Organizer for its own use (in its absolute discretion).
2. You hereby warrant that the information that you submit and/or distribute will not infringe the intellectual property, privacy or any other rights of any third party, and will not contain anything, which is libellous, defamatory, obscene, indecent, harassing or threatening and shall indemnify for (but without limitation to) any loss, damage or liability arising in connection therewith. If relevant, we reserve the right, but not the obligation (and without limiting our rights under your warranty and indemnity above), to screen, filter and/or monitor information provided by you and to edit, refuse to distribute or remove the same.

Section 4 – Confidentiality

You undertake not at any time to disclose, reveal, communicate or otherwise make public any confidential information relating to the Organizer, its business, personnel, contractors, agents or officers to anyone.

Section 5 – Data Protection

TNS ILRES will process personal data of the Participants for the purpose of organization, running of the Lottery and distribution of the prizes on behalf of the University of Luxembourg. Section 6 - Miscellaneous

1. The Terms supersede all prior representations, agreements, negotiations or understandings (whether oral or in writing). Except as specifically set out herein, all conditions, warranties and representations expressed or implied by law are excluded.
2. In the event that any provision of these terms are held to be illegal, invalid, void or otherwise unenforceable it shall be severed from the remaining provisions of these Terms which shall continue in full force and effect.
3. The failure to exercise or delay in exercising a right or remedy provided hereunder or by law does not constitute a waiver of the right or remedy or waiver of other rights or remedies.
4. These Terms are not intended to nor shall create any rights, entitlements, claims or benefits enforceable by any person that is not a party to them.

Section 8 - Jurisdiction

The Lottery and its Terms will be governed by the laws of the Grand Duchy of Luxembourg, and

the parties irrevocably submit any of their disputes they failed to settle amicably to the exclusive jurisdiction of the courts of Luxembourg City.
